TERMS AND CONDITIONS OF ENTRY

PROMOTION

HOW TO ENTER

5. You must be 18 and over to enter this promotion.
6. You may enter a maximum of one time.

PRIZES

7. Five prizes will be awarded, each prize comprising two general admission tickets to the Hokitika Wildfoods Festival occurring on 13 March, 2021.
8. Westland is not responsible for any winners’ travel arrangements to, or from The Festival.
